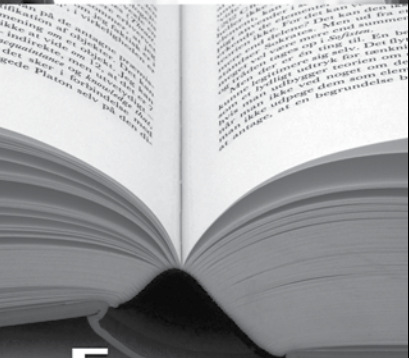

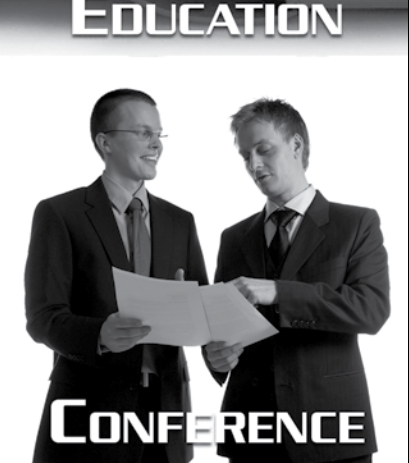

A Judicial Branch In Crisis

The parallels between Washington, D.C. and Sacramento are just breathtaking. Basically it is impossible to discuss issues pending in either venue without getting into budget and debt matters. Both the state and federal systems are polarized and dysfunctional, and both systems feature Democratic chief executives who have tried without success to craft solutions involving both cuts and "revenues." Both systems also feature moderate legislators who are facing criticism from the right and the left, making compromise difficult or impossible. And, both systems are leaving voters fed up!

For the purposes of CALSPro, the focus of the debate here in California is on the courts. In the past two years, general fund support for the court system has declined by approximately 30%. This year's general fund cut is \$350 million. At a recent meeting of the Judicial Council, the Administrative Office of the Courts were told to absorb cuts in the range of 12%, while the Supreme Court and courts of appeal took a share of approximately 10%, and trial courts lost between 6% and 7%. The net reduction to the trial courts for the current fiscal year which began on July 1 is \$135 million.

Determining the allocation of the \$135 million cut to the trial courts is not difficult. Each court will be forced to absorb its proportionate share of the total. Los Angeles, for example, represents just under 29% of the trial court system, amounting to a cut of approximately \$38 million. The

Judicial Council has a chart representing the share each court represents of the entire system, and the cuts are figured arithmetically.

Determining the impact of the cuts is far more difficult, because each court faces unique circumstances. Some have cut more in prior years, each has different pay scales and union contracts, and reserve amounts vary widely. Now that the \$135 million figure has been decided, each court is busy assessing the options for covering the loss.

We do know a few things, however. First, the impact of the cuts will be determined locally; there is no plan at this point for statewide court closures. Second, the civil system will bear the brunt of the cuts, as criminal trials, family law matters and others necessarily must have priority. Third, each court will have a different response to the cuts, whether by staffing changes, hours of operation, courtroom closures, or others. Fourth, and perhaps most ominously, unless something dramatic changes, next year could see even deeper reductions.

For the current fiscal year, the situation in the San Francisco Superior Court probably has received the most publicity. The presiding judge has announced an intention to lay off a staggering 200 employees, or 40% of the staff, and terminate 11 of 12 court commissioners, and close 25 courtrooms. If fully implemented, it is possible that as many as 14 of the 17 courtrooms currently

dedicated to civil matters will be closed. Obviously, time to trial will be lengthened dramatically and the civil system as we know it will change drastically.

Meetings are occurring with judicial branch leaders even as this column is written, to explore options. CALSPro members will hear the word "restoration" used; this refers to efforts to be undertaken with the legislature to restore previous cuts. Of course, the court system will not be the only governmental activity seeking to restore cuts taken in recent years. But, the Chief Justice and others will point out, this is more systemic than cutting programs of government. There are many worthy programs which have suffered cuts, but we are talking about a co-equal branch of government, literally a pillar upon which our democracy rests.

Options will be evaluated also during the final four weeks of this legislative year. The legislature returned from its summer recess on Monday, August 15, and will adjourn for the fall on Friday September 9. Will there be legislation to address the San Francisco situation? Will further fee increases be considered? Stay tuned.

That, along with supporting court funding to keep the courts open and accessible, and monitoring dozens of proposed changes to rules of court. The fun never ends! 🐾

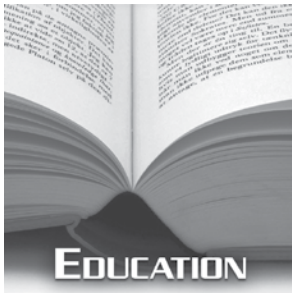

CCPS Exam to Be Given in Reno at the Annual Conference

On Sunday morning September 25, 2011 at 8:30 am there will be a 25 minute review for the CCPS Exam. This review will include a 2-sided study guide and cover material including process service timelines and the basic codes servers need to know, as well as general process serving information. The exam will begin at 9:00 am sharp, so if you are going to skip the review please plan on arriving 5 minutes early. The exam consists of 50 multiple choice questions, and you can earn the highly coveted CCPS designation with a score of 40 or more correct answers. The CCPS designation expires after 2 years; however, you may receive a 1 year extension before being required to test again by attending a CCPS workshop (while you are still current) in either of the 2 years following the year you earned your designation. Put your thinking caps on and I'll see you in Reno! 🇺🇸

2011 Bert Rosenthal Memorial Award

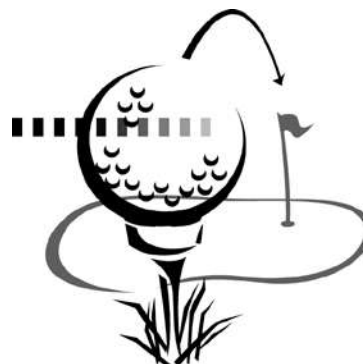
