COURT NEWS



During the shelter-in-place order in March, courts throughout California implemented different ways of operating. For example, some courts continued to process filings during this time, although at a far fewer volume than usual, while other courts had completely shut down and were not processing any filings at all.

Below are county court updates for Orange, Riverside and San Diego counties.

OTHER COURT UPDATES:

- Los Angeles Superior Court Civil has increased its Court Transaction Fee to \$2.25 starting
- July 1
- Kern County Superior Court will require mandatory electronic filing (eFiling) for all Probate case types starting Monday, August 3, 2020

Note: Due to COVID-19 restrictions, many courts continue to operate with reduced services and or hours. As the situation is ever-changing, please always check the **court's website** for the latest information.

Orange County Superior Court



The courthouses of Orange County Superior Court are open for limited in-person services. However, members of the public should NOT visit a courthouse unless they have been notified by the Court or they have scheduled an appointment to enter the building for counter services. The Court launched a new online scheduling tool to allow members of the public to self-schedule an in-person appointment at the public counters. Click Here.

Master Plan to Restore Court Services in Riverside Superior Court

The Riverside Superior Court is committed to protecting the health and safety of our community while performing our constitutional duties. The health and welfare of each judicial officer, employee, attorney, contractor, and member of the public that enters our facilities is paramount in the decisions that are made as the Riverside Superior Court begins to restore services. The Riverside Superior Court is closely monitoring local, state, and federal public health directives related to COVID-19, Centers for Disease Control and Prevention (CDC) guidelines and will continue to update the master plan as appropriate. This master plan for restoring services is fluid and will largely depend on policy-setting and guidance from the Judicial Council of California, and local, state and federal officials; therefore, this document will be updated periodically and further refined as the phases in the plan are solidified. **READ FULL PLAN HERE**

Proposed Changes to the San Diego Superior Court Rules



Proposed changes to the San Diego Superior Court local rules, with an effective date of January 1, 2021, have been approved by the Court in principle and submitted to the bar for comment in accordance with Rule 10.613 of the California Rules of Court.

Governor Newsom Announces New Statewide and County Closures

Effective immediately, California closes some indoor business operations statewide and additional indoor operations in counties on Monitoring List for 3 consecutive days.


Statewide indoor closures include restaurants, bars and breweries, wineries and tasting rooms, movie theaters, family entertainment centers, zoos and museums, and cardrooms. County indoor closures include fitness centers, places of worship and cultural ceremonies, indoor protests, offices for non-critical infrastructure sectors, personal care services, hair salons and barbershops, and malls. County closures apply to counties that have been on the County Monitoring List for 3 consecutive days. Learn more.

Know the Basics

We just had another successful CCPS Online Workshop on July 18. O ur next one is scheduled for August 22 so please be sure to signup if you are interested. If you have missed any of our free mini-webinars, be sure to check them out on the 'Member's Only' page of the CALSPro website.

One of our upcoming free miniwebinars will be on 'Getting Started' which is highly recommended for any new process server or for any staff vou may have in your office that is not as familiar with field work. This will focus on the basic knowledge needed to be prepared when going out to serve a paper.

Know the Basics

Most legal documents can be served by anyone who is at least 18 years old and not a party to the action.

However there are the following exceptions:

- ✓ Writs
- ✓ ORAPS/OEXS
- Pre Judgment Claims
 A person that serves over 10 papers per year



Note: A judge only has authority to issue a bench warrant if served by a Sheriff, Registered Process Server, or a person specially appointed by the court.

- Some people are exempt from registration: (B & P 22350)
 - Private Investigators his/her employees
 - Attorneys his/her employees (can only serve in their case)
 - A person that serves 10 or less papers per year properties in ALS
 - Sheriff, Marshal, or Constable*
 - Registered Professional Photocopiers
 - Only for service of subpoenas for the production of records by that photocopier
- Note: Generally, people exempt from registration cannot legally serve Writs, Pre Judgment Claims, or ORAPS (unless specially appointed by the Court).
 - *A California Sheriff may serve all types of Documents.

Judicial Council Revises Emergency Rule on Civil Filing Deadlines



The Judicial Council approved a revision to emergency rule 9 to adjust deadlines for filing civil cases during the COVID-19 pandemic, and to clarify that the emergency rule also applies to "statutes of repose." Statutes of repose are similar to statutes of limitation but establish deadlines for filing certain civil cases somewhat differently.
